Credo: CSLT inspires spiritual expression in community with all and offers an accepting, loving, and peaceful way of living a joyful, healthier, and more abundant life.

CSLT Online Community Presence:

<u>YouTube</u>: The recordings of our online services continue to be viewed on YouTube. During March there were 169 views (up) for 19 hours (up) and 108 total subscribers. Keith Gorley's Celebration of Life was watched by 24 people.

The two videos most watched were two regular Sunday Services on March 20th and March 27th.

<u>Instagram</u>: We have 99 Instagram followers (10 new ones).

If posting on Instagram is fun for you, and you want to participate this way, please let us know.

Newsletter Statistics: Five newsletters were sent during March to between 513-518 subscribers. Between 253-297 people (50-58%) opened them, and 18-32% of those who opened them clicked on something for further reading. These are truly incredible readership and participation response.

Morning Meditation. Daily practice continues, and a Sunday morning practice has been added. The current leaders have agreed to continue the daily morning practice through June 2022. We know that those participating get good value from the practice, and we/they are open to having others join in as they feel intrigued and called.

8e Covid 19 We make headway on having in-person services at a local theater. They have stringent, protective protocols which we will abide by. As a new facility, built during the pandemic, they have the volume and quality of air handlers which will reduce risks to humans. We will be following their physical distancing protocols & masking while inside. We augment their practices with color-coded nametags (green = hugs ok, yellow = ask me first, red = no contact, please).

8f Small Groups

Prosperity+ Alums meet online, 1st and 3rd Sundays 1-2pm in our second zoom room. New graduates invited to participate. Five people regularly attend. Good results are being achieved.

Janet Salese hosts Full Moon Labyrinth Walk as a regular activity for which we advertise and encourage participation of those interested. February's walk had no attendees. It was a cold and miserable night. Three persons attended March's walk. Janet is starting an email reminder for those who wish to participate, but keep forgetting. Twelve people showed up to walk the labyrinth on April 16th, several of whom were new.

Janet is planning to facilitate a "Pause for Peace" at 9am on Saturday May 7th at the Unity of Tucson's labyrinth for World Labyrinth Day. This activity is in collaboration with the Centers for Spiritual Living Heart of Peace initiative

^{*} We received anonymous designated gifts, part of which is to be used for 'sustainable' marketing activities. We called this the Opportunity Fund. Out of this account we have funded the website upgrade & partially funded of our Office improvement fund. We have also used this fund to test out other advertising opportunities and will use it for buying video equipment that will allow us to live-stream, when we return to in person services. 
